USC/CFALA CFA® Review Program

Since 1984, CFA Society Los Angeles, Inc. (CFALA), in partnership with the University of Southern California, Marshall School of Business (USC), has offered its Chartered Financial Analyst® (CFA®) Review Program to candidates studying for all three CFA examination levels. For Spring 2020, we offer streaming media recordings of Levels I, II and III. For Fall 2020, we offer streaming media recordings for Level I. Please note that these videos are recorded from our Spring 2020 Level I Review Program.

About Our Streaming Media Program

The USC/CFALA CFA Review Program features state-of-the-art streaming media recordings of structured classroom-based instruction by practitioners in the financial industry and academics from local universities. Instruction is focused on the

comprehension of the assigned materials in the Study Guides with an emphasis on the Learning Outcome Statements.

The program includes secure access to streaming media recordings of all study sessions. Level I recordings offer over 60 hours of instruction with bonus classes in study/test-taking tips, Accounting Essentials, an Accounting Review and Quant Review. Level II offers over 50 hours of instruction and Level III offers over 34 hours. PDFs of each instructor's PowerPoint presentation are included.

If you have high-speed internet access, the USC/CFALA CFA Review Streaming Media Program can provide you with a complete preparation course.



Viewing Requirements

Panopto

You can view these recordings on most browsers using a Windows, MAC OS, Linux, iOS, and Android operating systems. On desktop systems, a Flash player will need to be installed.

To ensure a trouble-free viewing experience, you need a minimum Internet connection speed of 1Mbps or more, and computer systems should meet the following minimum requirements:

Hardware:

 Desktop systems should have a minimum of 4GB of available hard-drive space, a high-speed internet connection, (1Mbps or greater), a monitor capable of a 1024 x 768 resolution or higher, a sound card, and speakers.

- IOS devices: iPad 2 and above, iPhone4 and above
- Android*: hardware that supports version 4.0 and above
- * Note: Android devices CANNOT be used to view live streams)

Software:

- Windows: Windows XP SP2 and above
- Mac OS: Mac OS X 10.5.7 or later (PPC-based not supported)
- iOS: 6 or higher
- Android OS: 4.0 or higher

You must have Adobe Flash installed on desktop systems to view streams! Most mobile devices will work – flash NOT required.

Browser

Any modern browser should work – the following have been tested and work fine. Earlier versions of these browsers may work, but cannot be guaranteed.

- Google Chrome: most recent version
- Firefox: most recent version
- Safari 10+
- Internet Explorer 11 and higher (including Edge, the Windows 10 native browser)

Include both forms with a copy of your DD214 (Separation from Military Service) and Letter of Disability Rating from the Department of Veteran Affairs.
