

We are very excited about Monday's first annual CFALA Golf Tournament. The event is sold-out and we are very grateful for the generous support from our sponsors and all participants and volunteers who plan on attending. It should prove to be a fun day of networking, great weather, and hopefully a few good golf shots. Prior to the event, we felt it necessary to review tournament format, logistics, and directions to avoid any uncertainty. **If you registered a group, please pass this email on to them as we do not have their contact info.**

#### **Tournament Format -**

- Four-person scramble format (Everyone hits a tee-shot, the most ideal shot is then selected, all players play their second shot from that location, and this process continues until the hole is completed).
- Each group must use a tee-shot from all members of the group at least once per nine-holes.
- Total gross score will determine the winners (Handicaps will not be used).
- Those who signed-up as individuals will be randomly paired-up with other groups prior to the tournament.

#### **Dress Code and Logistics -**

- Registration will begin at 11:45. The putting contest will take place from 12:00-12:45 and tee-off will be promptly at 1pm. Dinner is scheduled to begin by 6:30pm.
- There is no valet parking but plenty of complementary self-parking. Please feel free to drop your clubs off at the front circle prior to parking your vehicle. Please don't forget your clubs because there are no rentals available, if you need assistance contact Eric or Michael.
- All men must wear a collared shirt "polo acceptable" tucked in. Woman can wear either a collared shirt, blouse, or tank-top. Khaki style shorts (men- close to the knee) or pants are acceptable. Denim is not allowed. The dinner dress code is also casual golf attire.
- All golf shoes must have soft spikes, no metal spikes are allowed.
- We will be offering admission to a putting contest, selling mulligans and raffle tickets, and also have a par-3 competition hole. We will have a credit card machine that accepts payment for the aforementioned items, but cash is preferred. An ATM will not be available at the golf course.
- You must be present to win any raffle prizes.
- Beverages will be provided on the golf course (Water, soda, gatorade, beer).
- Lunch will not be provided nor can one be bought, but we will have snacks to hold you over.
- All proceeds will go directly to CFA Society of Los Angeles.

#### **Directions -**

- From Los Angeles - 5 South, 101 South, or 10 West to the 60 East. Exit Hacienda Blvd, turn right. Turn right on Colima Road. Turn left on Mar Vista Street. Turn right on Villaverde Drive. Golf course will be on the left-hand side.
- From Orange County - 5 North to Beach Blvd, turn right. Turn left on Whittier Blvd. Turn right on Colima Road. Turn right on Mar Vista Street. Turn right on Villaverde Drive. Golf course will be on the left-hand side.
- From Pomona/Riverside - 60 West, exit Hacienda Blvd, turn left. Turn right on Colima Road. Turn left on Mar Vista Street. Turn right on Villaverde Drive. Golf course will be on the left-hand side.
